Daventry District is a large, mainly rural area of 257 square miles in the west of Northamptonshire. It is the largest district in the county but, after Corby, has the second smallest population, with approximately 78,000 residents - the majority of whom live among the district's 78 villages. The district has one town - Daventry.

The district lies within the Milton Keynes/South Midlands Growth Area.

The boundaries of the Practice show we are large in terms of geographical size, with the majority of the land classified as rural. We are responsible for the healthcare of approximately 12,742 patients and our current premises have been built with growth in mind, to take up to 14,000 patients. The Practice area covers:
